

## Summary

EAUC-Scotland have been busy over the summer organising the Autumn session of TSNs; delivering a workshop for the TSN Convenors and grant proposal training; redeveloping our webpages; the HE CMP Review project; and meetings with a wide variety of members and strategic partners.

The team have also been working on:

RP has been developing the careers project and engaging with the Association of Graduate Careers Advisory Service; manages newsletter communications and will be developing webinars from next month while also continuing the planning of the EAUC-S Conference for November;

GG has continued to engage with members through events and meetings, provides a secretariat role for the new Edinburgh regional group; manages regular Key Contacts updates under the UCCCfS and manages our social media communications;

SL is working with the Scottish Government and the Climate Leaders Officers Group (CLOG) on reporting requirements for the public sector, the HE CMP review, and commissioning research through HEA-S and Learning for Sustainability Scotland (LfSS) on sustainability leadership to develop a programme;

A survey will be circulated to Scotland contacts in Sept to assess the effectiveness of the UCCCfS and Scotland Programme and to gather useful insight into further support and guidance required by EAUC-Scotland for the sector.
