What has changed?

- Regulation (EC) 1774/2002 and
- ABP(S)R 2003 revoked
- Replaced by
- (Control) Regulation (EC) 1069/2009 and
- (Implementing) Regulation (EC) 142/2011
- ABP(E)(S)R 2011

Main Point

- Introduce the concept of Registration at Article 23 of the enforcing regulations.
- Continues the requirement of Approval for some premises/operators at Article 24 of the enforcing regulation.

What are ABPs?

- Defined in Articles 8, 9 and 10 of the Control Regulations.
 - Art' 8 - cat 1 material
 - Art' 9 - cat 2 material
 - Art' 10 - cat 3 material

Obligations regards ABP Disposal.

- Article 12, 13 and 14
- Art' 12 – Cat 1 material
 - Rendering/Incineration
- Art' 13 – Cat 2 material
 - Incineration
 - Rendering then composting
- Art' 14 – Cat 3 material
 - Various options, pet food, composting etc



Derogations.

Article 16 provides for various derogations.

16 (a) used for research and other specific purposes in accordance with Article 17.

Article 17


- Research and other specific purposes
 - Exhibitions, artistic activities, diagnostic, educational or research purposes under conditions which ensure the control of risks to public and animal health
 - Prohibits any subsequent use of the ABP
 - Must dispose of ABP/derived products safely/re-dispatch to place of origin

Who needs to be registered?

- Anyone producing , handling processing, etc ABPs must be either registered or approved under the ABP regulations.
- Excludes sites that produce ABPs as a result of activities where animals are kept, bred or taken care of i.e. farms excluded.

How do I register?

- Final mechanism not yet in place
- Temporary system
 - Contact local AHVLA Office
 - Specify who, what and where
 - Edinburgh Uni
 - Educational use
 - Research use
 - Various university sites
 - You will be given permission to proceed.
 - LA informed and RA to decide if inspection required.

- 
- Final system will require
 - Download of application form from AHVLA website
 - Return completed form specifying all activities you wish to carry out to local office
 - RA carried out and registration recommended to the SG will issue registration document

Once Registered

- You can use the derogations

Obligations

- Article 21 – Collection, transport and traceability.
- Article 28 – Own checks
- More specific detail is at Annex VI of (implementing) Regulation (EC) 142/2011



142/2011

- Annex VI, Chapter 1, Section 1
- Defines how samples must be produced / handled.
 - Commercial document required
 - Avoid spreading disease
 - Good lab practice
 - Only research use
 - Disposed of by incineration
 - Liquids, cell cultures autoclave them as waste legislation.
 - Register of consignments
 - Include date of disposal

Commercial document.

- Description of material plus species
- Category of material
 - 1
 - 2
 - 3
- Quantity
- Place of origin and dispatch
- Name and address of consignor
- Name and address of consignee and/or user



Educational

- Low risk activities are allowed to operate outside the regulations provided risks are low and controlled
 - Schools
 - Dissection of frogs
 - Looking at bovine/ ovine hearts, lungs etc

Farms


- Must comply with the regulations but no need for approval / registration unless carrying out some other specific operation.
 - Low capacity incinerator
 - Registered for the return of hides/skins
 - Required to produce commercial documents for the disposal of ABP

Catering Waste

- No change to the definitions of catering waste
- Out of scope unless disposed by
 - Processing, (Rendering) now allowed
 - Composting/Biogas
 - Can still be land filled

Composting

- Old regulations allowed for a regulation 16 exemption where you composted/AD your own waste and used the products yourself
- This exemption to the regulations has disappeared. Nothing equivalent in the new regulations!

- Aim by policy makers to continue to allow and even expand the use of an equivalent of the old regulation 16.
 - Currently looking at publishing guidance to allow this however wording is proving difficult so watch this space.



How will it be expanded?

- Possibly to allow a university to have a central composting facility
 - Will allow all material to be composted on the one site
 - Products can be used on the whole university estate
 - Removal of the tight restriction regards definition of the site
 - May place a maximum tonnage per year to be able to operate outside controls
 - No livestock


- Free trade in theory

- Importation of Animal Products & Poultry Products Order 1980. (IAPPPO)
- Importation of Animal Pathogens Order
- SAPO

Importation summary

- Import in accordance with Regulations (EC) 1069/2009 and 142/2011
- Importation must have been authorised by the member state
 - Application form IAPPPO 1 (Rev. 09/09) plus Supplementary form IAPPPO 1 Supp (Rev.04/09)
 - Available from Spur P, Saughton House, Edinburgh, EH1 13XD

- 
- Subsequent use prohibited.
Cannot be used commercially.
 - Disposed of by
 - Incineration
 - Pressure sterilisation
 - Autoclaved if <2000ml and from specified countries
 - See Annex XIV ChapterIII, Section I
