	Scotland Office Report (SL)	
	The Scotland Office Report can be viewed <a href="https://example.com/here">here</a> EAUC-Scotland currently working to SFC outcome agreement - meet with SFC quarterly to update on activity and impact in the sector. The UCCCfS have been signed by all HE/FE institutions in Scotland. Still looking for everyone to have their CCAPs up to date and reporting now mandatory through Scottish Government Climate Change Duties. Working in partnership with RES, ZWS, SSN, SAUDE.	
	AA: SLC now in 5th year of their CCAP and looking to update and renew - this is potentially big focus across the HE/FE sector in Scotland for those that will need updating SL: EAUC-S is here to support people updating Plans and the format is more flexible, creating a dynamic working document that fits your institution and aligns to reporting rather than the old CCAP template. FL: Are the SFC happy with this flexible arrangement, as the universities outcome agreements specify that a CCAP is needed. Problematic area is finding funding for projects on project register. SL: CCAPs are still necessary however it doesn't need to be the previous template outlined, such as Carbon Trust version.	

BG: Will the Salix loan be applicable for FE at any point?

SL: At the moment no unfortunately due to the college classification, the Minister would have to sign off every application.

ML: Workshop on decarbonisation and targets/ planning would be useful SL: Working with Carbon Credentials and RES/SSN to help with this work and is in our yearly work programme.

MW: Currently working on SFC Central Energy Efficiency Pathfinder project as there is no capital or Salix funding for the college.

JT: Would be good to be kept up to speed on legal requirements.

ML: University of Edinburgh are currently running three projects through SFC: high level carbon production tool, sector best practise, business model for renewables.

SL: EAUC-S has also produced a technologies catalogue with RES, it can be found on the Sustainability Exchange <a href="here">here</a>.

AA: SLC received feedback on the Climate Change Duties Required Reporting from SSN. It was fair and a lot of the sections in the report were to be completed the next year.

SL: 110 bodies submitted reports from 151 public bodies, therefore SSN couldn't give individual feedback on everything. We will be working on collating the data for FE/HE to create a report for SFC on sector progress this will be circulated in the next month once submitted.

MW: It would be preferred to have it peer review, rather than a league table from the reporting

SL: Analysis will be happening on all the data as sectors and there is no intention for a league table will be produced.

AA: Risk in some areas where data can and cannot be quantified easily which could produce errors/variation and subsequently reflect badly on the real data. E.g. travel/business travels.

#### Final comments from SL:

- As EAUC-S review the programme and member survey a continuation of honest feedback from the sector is appreciated.
- Moving away from primarily estates and carbon activity, looking to incorporate more into Learning for Sustainability. Exploring a wider scope that sustainability can be implemented into.
- Topic Support Network for ESD for HE and FE. Good turnout of people attending the next HE meeting, higher than average for TSNs.

JJ: SFC colleagues have discussed that EAUC-Scotland are doing a great job!

- Lack of involvement of managers with no direct remit for sustainability in their job descriptions.
- Lack of leadership on sustainability in institutions
- Most colleges lack the full-time resource

- Reliance on grant income
- Small team
- Sustainability in procurement

#### **Opportunities**

- Delivery of Scottish Government goals high on their agenda
- Different partnership funding arrangements
- Formal FE tools and qualifications (e.g. the FE ESD workbooks but for other sectors)
- Greater influence with SFC support
- Income generation from training & consultancy to replace grant
- Links to HR priorities
- Networks HE/FE/CDN etc.
- Retaining membership fees in Scotland
- Sharing skills due to diversity in membership
- Student enthusiasm for ESD

### **Threats**

- Alternative support available (e.g. SSN)
- Budget squeeze resulting in membership reduction
- Commercial based organisations attempting to provide similar services with less expertise business strategy rather than values strategy
- Demand on services of small team
- Demands on institutions" officers' time
- Green overload, misinformation based on poor science
- Lack of funds to market across UK/share good practise
- Lack of urgency in the sector
- Reduced priority on ESD due to funding environment
- Scope of sustainability increasing but not capacity
- Unrealistic targets (e.g. 80%carbon emission reduction)

# Post 2017- until 2020

- Advocate changes to match policies on the ground
- As climate change action plans are implemented, greater focus on other areas of sustainability (e.g. Fairtrade)
- Career pathways
- EAUC to spend time in member organisations for staff swaps, learning/capacity
- Going beyond already engaged managers and move to full engagement
- Guidance helping organisations interpret policy briefs
- Integration of sustainability (not "others")
- Links with employers to work with FE & HE to roll out sustainability into the work place (CRS)
- More interaction with senior management
